ABOUT THE ORGANISATION

The European Democratic Party (EDP) founded by François Bayrou and Francesco Rutelli in 2004, is a centrist European political party that gathers political parties and MEPs who want a Union closer to the citizens who live in it. As a transnational political movement, the EDP intends to build a European democracy that is rooted in the shared values of peace, freedom, solidarity and education, having the ambition to proudly affirm its culture in the future world.

The EDP has currently 11 MEPs from 5 countries and 18 Member organisations from 14 countries.

ABOUT THE CALL FOR TENDERS

The European Democratic Party is seeking to engage in a long-term partnership with a external consultant on political and communications work to support the organisation's operational activities.

The EDP is funded by the European Parliament and is being regulated under the Regulation (EU, Euratom) No 1141/2014.

This call is also regulated under Article II.9 of the Funding Agreement between political parties and foundations and the European Parliament.

TENDER REQUIREMENTS

With a second part of the mandate and the preparation of the new European elections campaign in 2024, the EDP is looking for a technical assistance in the area of communications, its network development and organising events. The contractor or contractors is/are required to provide the following services:

- Political work
 - In cooperation with the EDP Secretariat, identify and assess the party's organisational capacities and the needs of European Democrats.

 - Production and Development of documents and communication materials to promote and explain the activities of the EDP to its members and MEPs.

- Design, preparation and organisation of events to promote and explain the activities of the EDP, its members and its MEPs.
